

All members in good standing with current loans (less than 15 days past due in the past 12 months) are eligible for our Skip-A-Pay program! For a limited time only, the \$25 application fee for Skip-A-Pay is waived - it's our gift to you this holiday season!

The following loans are not eligible for this program: Master Card Credit Card, Mortgage Loan, Home Equity Loan, Home Equity Line of Credit, Down Payment Assistance Loan, Student Loan and Student Loan Consolidation. This request must be received no less than 10 business days prior to the payment you want to skip.
